International Trucks will have the following charges added for the 2010 emissions compliant engines. The charge for all Maxforce DT, Maxforce 9 and 10 engines will be \$6,000.00 (Specifications 55, 56 and 57). The charge for all Maxforce 11 and 13 engines will be \$8,000.00 (Specifications 58 and 59). The International trucks listed in Specifications #51 and #54 are discontinued effective immediately.

Western Star trucks, awarded to Tampa Truck Center, have been required to increase prices due to changes that include the addition of Selective Catalytic Reduction (SCR) and an engine change from the MBE 4000 to the DD13. These changes have resulted in a price increase of approximately \$12,300 to meet the 2010 EPA Emissions Standards.
